

I. Declaration of consent of the participant to the general conditions of participation and to the data protection declaration

- In the event of willful and gross damage to the course or the industrial trucks and disregard of the referee's instructions, immediate disqualification will result.
- I only took part in one regional championship / national qualifier for the StaplerCup this year.
- I confirm that I am not a current employee of the KION Group (including its subsidiaries), the authorized dealers of Linde MH GmbH or one of the national companies/international authorized dealers of Linde MH.

The personal data required for registration and the organization of the event will be requested from the participants in the registration form.
2. Documentation of the event/publication and use for corporate communications:
 - a. For the purpose of publication and use for corporate communications, personal data will be published on the website www.staplercup.com, in results press releases and in digital and print media as part of reporting, especially in rankings (ranking and results lists) and, if necessary, in connection with the photos of the individual participant or several participants as part of reporting and made available to reporting media for use for the purpose of reporting.
 - b. In the event that a participant takes one of the first three places in the respective national qualifier competitions (previously regional championships or international qualifiers) or in the StaplerCup Finals, the Forklift World Championship in the disciplines Men's Forklift World Championship / Women's Forklift World Championship / Team Forklift World Championship / Corporate Cup (no World Championship), the above personal data of the participant in this section, together with a photo of the award ceremony, will be published on the website www.staplercup.com and made available to the media reporting on the results in this way and made available for retrieval and download.
3. Legal retention periods/storage period:
Participant data will be retained and stored for as long as is necessary for the purpose for which the data was collected in a permissible manner or as long as retention is required due to statutory or legal obligations. If such statutory/legal retention obligations exist, this data will be blocked or deleted at the end of these retention obligations.
